**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via
 SMALL VALUE PROCUREMENT TO GLYPTIC ART ENTERPRISE FOR THE
 SUPPLY AND DELIVERY GLASS PLAQUES AND CERTIFICATE FRAMES (LOT 1) AND
 DARA CONSUMER GOODS TRADING FOR THE SUPPLY AND DELIVERY OF
 WRIST WATCHES (LOT 2) FOR RETIREE INCENTIVES**

WHEREAS, the Philippine Information Agency – Human Resource Development Division (HRDD) submitted its Purchase Request for the **Supply and Delivery of Glass Plaques and Certificate Frames (LOT 1) and Wrist Watches (LOT 2) for Retirees' Incentives** with an Approved Budget for the Contract (A.B.C.) of **NINETY-FOUR THOUSAND FIVE HUNDRED PESOS ONLY (Php 94,500.00)** inclusive of tax and included in the Annual Procurement Plan of the Agency;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website and sent the same to the various prospective suppliers on 20 May 2022;

WHEREAS, the posting was divided into Lots 1 and 2 with details as follows:

WHEREAS, after the closing date on 24 May 2022, only Glyptic Art Enterprise submitted its quotation for Lot 1 and only Dara Consumer Goods Trading submitted its quotation for Lot 2 appearing herein as ANNEX A and the Abstract of Quotation as Annex B;

WHEREAS, hereunder is the summary of the quotations received:

WHEREAS, the quotations submitted by **Glyptic Art Enterprise for Lot 1** and **Dara Consumer Goods Trading for Lot 2** were subjected to Virtual Post Qualification assessment by the designated members of the Technical Working Group (TWG) on 31 May 2022 and 3 June 2022 respectively;

WHEREAS, after evaluation of the submitted quotations and other pertinent documents, the TWGs found that **Glyptic Art Enterprise for Lot 1** and **Dara Consumer Goods Trading for Lot 2** are legally, financially, and technically capable to undertake the subject procurement, and for having submitted a responsive quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, in consideration of the foregoing, **WE**, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMENDS** the award via Small Value Procurement to the following suppliers:
