**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via  
 SMALL VALUE PROCUREMENT TO CARFAM LOGISTICS SERVICES  
 FOR THE PROCUREMENT OF TRUCKING AND HAULING SERVICES  
 FOR THE TRANSFER OF PIA-MIMAROPA REGIONAL OFFICE  
 TO CALAPAN CITY, ORIENTAL MINDORO**

**WHEREAS**, the Philippine Information Agency – MIMAROPA (PIA REGION IV-B) submitted its Purchase Request for the **PROCUREMENT OF TRUCKING AND HAULING SERVICES FOR THE TRANSFER OF PIA-MIMAROPA REGIONAL OFFICE TO CALAPAN CITY, ORIENTAL MINDORO** with an Approved Budget for the Contract (A.B.C.) of **SIXTY THOUSAND PESOS ONLY (Php 60,000.00)** inclusive of VAT and other charges;

**WHEREAS**, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

**WHEREAS**, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website and sent the same to the various prospective suppliers on 6 June 2022;

**WHEREAS**, after the closing date on 9 June 2022, the following service providers submitted their quotation namely 1) Carfam Logistics Services; 2) EMR Courier Services International Inc; and 3) "K" Line Logistics (Phils.) Inc. herein as ANNEX A and the Abstract of Quotation as ANNEX B;

**WHEREAS**, hereunder is the summary of the quotations received:

**WHEREAS, Carfam Logistics Services** quotation was subjected to Virtual Post Qualification assessment by the designated Technical Working Group (TWG) on 20 June 2022;

**WHEREAS,** upon validation of submitted documents, the designated TWG found that **Carfam Logistics Services** is legally, financially, and technically capable to undertake the subject procurement, and for having submitted the lowest and most responsive quotation;

**WHEREAS,** the proposal of **Carfam Logistics Services** for the **Procurement of Trucking and Hauling Services for the Transfer of PIA-MIMAROPA Regional Office to Calapan City, Oriental Mindoro** conforms to the requirements of PIA and the law and its price quotation of **FIFTY-SEVEN THOUSAND PESOS ONLY (Php 57,000.00)**, inclusive of tax, is within the ABC, and most advantageous to the government, thereby rendering the same as the most responsive quotation;

**WHEREAS,** Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

**NOW, THEREFORE,** for all in consideration of the foregoing, **WE,** the Members of the **PIA BIDS AND AWARDS COMMITTEE,** by virtue of the powers vested on us by law, hereby **RECOMMEND** the award of contract via **Small Value Procurement** to **CARFAM LOGISTICS SERVICES** for the **PROCUREMENT OF TRUCKING AND HAULING SERVICES FOR THE TRANSFER OF PIA-MIMAROPA REGIONAL OFFICE TO CALAPAN CITY, ORIENTAL MINDORO** in the amount of **FIFTY-SEVEN THOUSAND PESOS ONLY (Php 57,000.00)** inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
