**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via  
 SMALL VALUE PROCUREMENT TO AGMS INFORMATION TECHNOLOGY SOLUTIONS  
 FOR THE PROCUREMENT OF CLOUD BASED HOSTING, WEBSITE MAINTENANCE,  
 ANALYTICS, OPTIMIZATION SERVICES FOR THE PIA WEBSITE FROM  
 APRIL TO DECEMBER 2022**

**WHEREAS**, the Philippine Information Agency – Creative Production Services Division (CPSD) submitted its Purchase Request for the **PROCUREMENT OF CLOUD BASED HOSTING, WEBSITE MAINTENANCE, ANALYTICS, OPTIMIZATION SERVICES FOR THE PIA WEBSITE FROM APRIL TO DECEMBER 2022** with an Approved Budget for the Contract (A.B.C.) of **FOUR HUNDRED FIVE THOUSAND PESOS ONLY (Php 405,000.00)** inclusive of tax and included in the Annual Procurement Plan of the Agency;

**WHEREAS**, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

**WHEREAS**, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website and sent the same to the various prospective suppliers on 22 March 2022;

**WHEREAS**, after the closing date on 25 March 2022, the following suppliers submitted their quotations namely 1) AGMS Information Technology Solutions; 2) Sophie's Information Technology Services (SitesPhil); and 3) K2C General Merchandise (Quanby IT Solutions) appearing herein as ANNEX A and the Abstract of Quotation as ANNEX B.

**WHEREAS**, hereunder is the summary of the quotations received:

**WHEREAS, AGMS Information Technology Solutions and Sophie's Information Technology Services (SitesPhil)** quotation were subjected to Virtual Post Qualification assessment by the designated Technical Working Group (TWG) and end-user representative on 31 March 2022;

**WHEREAS,** upon validation of documents and virtual ocular inspection conducted on the said date, the designated TWG found that **AGMS Information Technology Solutions** is legally, financially, and technically capable to undertake the subject procurement, and for having submitted the lowest and most responsive quotation;

**WHEREAS,** the proposal of **AGMS Information Technology Solutions** for the **Procurement of Cloud Based Hosting, Website Maintenance, Analytics, Optimization Services for the PIA Website from April to December 2022** conforms to the requirements of PIA and the law and its price quotation of **TWO HUNDRED SEVENTY THOUSAND PESOS ONLY (Php 270,000.00)**, inclusive of tax, is within the ABC, and most advantageous to the government, thereby rendering the same as the lowest and most responsive quotation;

**WHEREAS,** Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

**NOW, THEREFORE,** for all in consideration of the foregoing, **WE,** the Members of the **PIA BIDS AND AWARDS COMMITTEE,** by virtue of the powers vested on us by law, hereby **RECOMMENDS** the award of contract via **Small Value Procurement to AGMS INFORMATION TECHNOLOGY SOLUTIONS** for the **PROCUREMENT OF CLOUD BASED HOSTING, WEBSITE MAINTENANCE, ANALYTICS, OPTIMIZATION SERVICES FOR THE PIA WEBSITE FROM APRIL TO DECEMBER 2022** in the amount of **TWO HUNDRED SEVENTY THOUSAND PESOS ONLY (Php 270,000.00)** inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
