RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via SMALL VALUE PROCUREMENT TO VIVA SALES ENTERPRISES FOR LOT 1 - VARIOUS CARPENTRY SUPPLIES AND MATERIALS AND LOT 4 - VARIOUS PAINTING, OTHER SUPPLIES AND MATERIALS,

WHEREAS, the Philippine Information Agency – Administrative Division (ADMIN) submitted its Purchase Request for the PROCUREMENT OF LOT 1 - VARIOUS CARPENTRY SUPPLIES AND MATERIALS, LOT 2 – VARIOUS ELECTRICAL SUPPLIES AND MATERIALS, LOT 3 - VARIOUS PLUMBING SUPPLIES AND MATERIALS, LOT 4 – VARIOUS PAINTING, OTHER SUPPLIES AND MATERIALS AND LOT 5 - ONE (1) UNIT BATTERY 3SMF with an Approved Budget for the Contract (ABC) of SEVEN HUNDRED SEVENTY THOUSAND TWO HUNDRED FOUR PESOS only (Php 770, 204.00) inclusive of tax and included in the Annual Procurement Plan of the Agency;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (53.9) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the at the PhilGEPS website, PIA website, PIA official social media account and sent the same to various prospective service providers on 29 April 2023;

WHEREAS, the Purchase Request and posting was divided into five (5) Lots with details as follows:

One (1) unit of Battery 3SMF. The above mentioned suppliers were subjected to post qualification evaluation by the designated Member of the Technical Working Group (TWG) on 16 May 2023;

WHEREAS, after careful evaluation, validation and verification of all the eligibility, technical and financial requirements, the submitted quotation of VIVA **SALES ENTERPRISES** for Lot 1 - Various Carpentry Supplies and Materials and Lot 4 - Various Painting, Other Supplies and Materials, BOSTON BUILDER'S **CENTER** for Lot 2 - Various Electrical Supplies and Materials and Lot 3 - Various Plumbing Supplies and Materials and LUZON SALES CO., INC for Lot 5 - One (1) unit of Battery 3SMF were found to conform to the requirements of PIA and the law and its price quotation of TWO HUNDRED FORTY-TWO THOUSAND SEVEN HUNDRED SEVENTY-SEVEN PESOS ONLY (Php 242,777.00) for Lot 1 , ONE HUNDRED SEVENTEEN THOUSAND EIGHT HUNDRED EIGHTY-FIVE PESOS ONLY (Php 117,885.00) for Lot 2, ONE HUNDRED EIGHT THOUSAND SEVEN HUNDRED SIXTY PESOS ONLY (Php 108,760.00) for Lot 3, ONE HUNDRED THIRTY-ONE THOUSAND FIVE HUNDRED TWENTY-TWO PESOS 60/100 ONLY (Php 131,522.60) for Lot 4 FIVE THOUSAND NINE HUNDRED **EIGHTY PESOS ONLY (Php 5,980.00)** for Lot 5, were inclusive of tax, are within the ABC, and are the most economical and advantageous to the government, thereby rendering both as the Lowest Calculated and Responsive Quotations;
