RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via SMALL VALUE PROCUREMENT TO R BROS ENTERPRISES FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT AIRCONDITIONING UNITS

WHEREAS, the Philippine Information Agency – Administrative Division (ADMIN) submitted its Purchase Request for the **Supply and delivery of One (1) lot Airconditioning Units** with an Approved Budget for the Contract (ABC) of **FOUR HUNDRED NINETY THOUSAND PESOS ONLY (Php 490,000.00)** inclusive of tax and included in the Annual Procurement Plan of the Agency;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H – Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website, the official website of the PIA as Procuring Entity, PIA social media platforms and sent the same to various prospective suppliers on 23 June 2023;

WHEREAS, after the closing date on 29 June 2023, the following suppliers submitted their quotations namely 1) Luxenberg Marketing, Inc; 2) R Bros Enterprises; 3) CP PAR-LAY International Corp; 4) Amigotek Corporation; 5) Apex Office Supplies and Equipment Trading; 6) Expanded-Aire Enterprises; 7) Aequus Enterprise; 8) Vistaire Builders and Airconditioning Sales and Services Inc; and Clearshot Builders, OPC appearing herein as ANNEX A and the Abstract of Quotation as ANNEX B;

WHEREAS, hereunder is the summary of the abovementioned:

WHEREAS, all of the nine (9) prospective suppliers submitted their quotations within the ABC. The lowest submitted quotation of **LUXENBERG MARKETING, INC** was subjected to on-site post qualification assessment by the designated member of the Technical Working Group (TWG) on 7 July 2023. Luxenberg Marketing did not provide nor present sample aircon unit as specified in their proposal. Thus, the TWG was not able to check the required technical specifications. Moreover, Luxenberg Marketing was not able to submit a notarized omnibus sworn statement;

WHEREAS, the designated TWG proceeded to conduct on-site post qualification assessment to the second lowest submitted quotation from **R BROS ENTERPRISES** on 11 July 2023;

WHEREAS, after review and evaluation, the TWG found that **R BROS ENTERPRISES** is legally, financially, and technically capable to undertake the subject procurement, and for having submitted a responsive quotation;

WHEREAS, as provided for in the GPPB Manual of Procedures for the Procurement of Goods and Services, Volume 2, the concept of value for money is not restricted to price and includes non-cost factors like suitability of fitness to the purpose, quality, etc. among other factors including completeness and compliance to the requirements;

WHEREAS, the proposal of **R BROS ENTERPRISES** for the **Supply and delivery of One (1) lot Airconditioning Units** conforms to the requirements of PIA and the law and its price quotation of **Four Hundred Thirty-Nine Thousand Eight Hundred Ninety Pesos Only (Php 439,890.00)**, inclusive of tax, is within the ABC, and thereby rendering the same as the most responsive quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, in consideration of the foregoing, **WE**, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMENDS** the award via *Small Value Procurement* to **R BROS ENTERPRISES** for the **SUPPLY AND DELIVERY OF ONE (1) LOT AIRCONDITIONING UNITS** in the amount of **FOUR HUNDRED THIRTY-NINE THOUSAND EIGHT HUNDRED NINETY PESOS ONLY (Php 439,890.00)** inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
