RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via SMALL VALUE PROCUREMENT TO POWER HOUSE PEST CONTROL SERVICES FOR THE PEST AND TERMITE CONTROL AND ERADICATION

WHEREAS, the Philippine Information Agency – Administrative Division (Admin) submitted its Purchase Request for the PEST AND TERMITE CONTROL AND ERADICATION (JULY TO DECEMBER 2023) with an Approved Budget for the Contract (ABC) of ONE HUNDRED EIGHTY THOUSAND PESOS ONLY (PHP 180,000.00) inclusive of tax and included in the Annual Procurement Plan of the Agency;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website and sent the same to the various prospective suppliers on 15 May 2023;

WHEREAS, after the closing date on 19 May 2023, four (4) prospective suppliers submitted their quotations namely; 1) Power House Pest Control Services, 2) Q & L Pest Control Services, 3) Sir Vokz Pest Management OPC and 4) Gigacom Pest Control Services appearing herein as ANNEX A and the Abstract of Quotation as Annex B;

WHEREAS, hereunder is the summary of the price quotations received:

WHEREAS, POWER HOUSE PEST CONTROL SERVICES submitted the lowest quotation and was subjected to Post Qualification Assessment by the designated Technical Working Group (TWG) on 25 May 2023;

WHEREAS, after review and evaluation of the submitted quotation and other eligibility documents, the TWG found that POWER HOUSE PEST CONTROL SERVICES is legally, financially, and technically capable to undertake the subject procurement, and for having submitted the Lowest Calculated and Responsive Quotation (LCRQ);

WHEREAS, the proposal of POWER HOUSE PEST CONTROL SERVICES conforms to the requirements of PIA and the law and its price quotation of Eighty-Seven Thousand Seven Hundred Seventy Pesos Only (PHP 87,770.00) inclusive of tax, is within the ABC, and the most economical and advantageous to the government, thereby rendering the same as the responsive quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, in consideration of the foregoing, We, the Members of the PIA BIDS AND AWARDS COMMITTEE, by virtue of the powers vested on us by law, hereby RECOMMEND the award via Small Value Procurement to POWER HOUSE PEST CONTROL SERVICES for the PEST AND TERMITE CONTROL AND ERADICATION (JULY TO DECEMBER 2023) in the amount of Eighty-Seven Thousand Seven Hundred Seventy Pesos Only (PHP 87,770.00) inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
