**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via  
SMALL VALUE PROCUREMENT TO LAI'S CATERING SERVICES  
FOR THE SUPPLY AND DELIVERY OF PACKED MEALS & SNACKS FOR  
THE PARTICIPANTS OF THE ISO 9001:2015 QUALITY MANAGEMENT  
SYSTEM REQUIREMENTS & DOCUMENTATION TRAINING COURSE ON  
31 JULY - 03 AUGUST 2023**

**WHEREAS**, the Philippine Information Agency – Office of the Deputy Director-General for Quality Management, Legislative Liaisons and Special Projects submitted a Purchase Request for the **SUPPLY & DELIVERY OF PACKED MEALS & SNACKS FOR THE PARTICIPANTS OF THE ISO 9001:2015 QUALITY MANAGEMENT SYSTEM REQUIREMENTS & DOCUMENTATION TRAINING COURSE ON 31 July - 03 August 2023** with an Approved Budget for the Contract (ABC) of **SIXTY-FIVE THOUSAND ONE HUNDRED TWENTY PESOS ONLY (PHP 65,120.00)** inclusive of tax and included in the Annual Procurement Plan of the Agency;

**WHEREAS**, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

**WHEREAS**, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and causes the posting at the PhilGEPS website and sent the same to the various prospective suppliers on **22 July 2023**;

**WHEREAS**, after the closing date on **25 July 2023**, **only LAI'S CATERING SERVICES submitted a quotation** appearing herein as ANNEX A and the Abstract of Quotation as Annex B;
