**WHEREAS**, pursuant to Civil Service Commission Resolution No. 1300455, wherein every office/agency shall have a Review and Compliance Committee;

**WHEREAS**, in compliance to the CSC Resolution, the PIA Review and Compliance Committee was reconstituted thru PIA Office Order No. 130, s. 2019 and Office Order No. 033, s. 2022;

**WHEREAS**, there is a need to designate a new composition of the secretariat;

**WHEREAS**, Section 40 of Executive Order No. 292, s. 1987 allows the Head of Agency to delegate functions for a more efficient and effective delivery of services;

**NOW THEREFORE**, for and in consideration of the foregoing, and in the exigency of service, the undersigned hereby orders the following:

**Section 1. Reconstituting the PIA Review and Compliance Committee.** Amending Office Order No. 130, s. 2019, the PIA Review and Compliance Committee shall be composed of the following:

**Section 2. Mandate.** The Review and Compliance Committee is designated and authorized by the Head of the Agency to receive the Statement of Assets Liabilities and Networth (SALN), and to evaluate if the same has been submitted on time, complete and in proper form.

**Section 3. Complete dissemination.** The Records Section shall furnish copies of this Order to all personnel of PIA as well as the resident auditors of COA.



**Section 5. Repealing Clause.** All Orders or issuances not consistent herewith are considered repealed/ superseded/ amended accordingly.


**Section 6. Effect.** This Order shall take effect immediately.
