**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via
SMALL VALUE PROCUREMENT TO VIVA SALES ENTERPRISES
FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT OF VARIOUS
SUPPLIES AND MATERIALS FOR REPAIR OF THE AGENCY OFFICES**

WHEREAS, the Philippine Information Agency – Administrative Division (ADMIN) submitted its Purchase Request for the **Supply and delivery of One (1) lot of Various Supplies and Materials for Repair of the Agency Offices** with an Approved Budget for the Contract (ABC) of **ONE HUNDRED SIXTY-FOUR THOUSAND EIGHT HUNDRED PESOS ONLY (Php 164,800.00)**, inclusive of tax and included in the Annual Procurement Plan of the Agency;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H – Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website, the official website of the PIA as Procuring Entity, PIA social media platforms and sent the same to various prospective suppliers on 5 September 2023;

WHEREAS, after the closing date on 9 September 2023, the following suppliers submitted their quotations namely 1) Ace Hardware Philippines, Inc; and 2) Viva Sales Enterprises appearing herein as ANNEX A and the Abstract of Quotation as ANNEX B;

WHEREAS, hereunder is the summary of the abovementioned:

1. ACE HARDWARE PHILIPPINES, INC. <i>(incomplete quotation)</i>	79,162.75
2. VIVA SALES ENTERPRISES	164,000.00

WHEREAS, the bid of **Ace Hardware Philippines, Inc.** was found nonresponsive after submitting an incomplete quotation. Thus, the subsequent prospective supplier **Viva Sales Enterprises** was subjected to post qualification assessment by the designated member of the Technical Working Group (TWG) on 20 September 2023;

WHEREAS, after review and evaluation, the TWG found that **VIVA SALES ENTERPRISES** is legally, financially, and technically capable to undertake the subject procurement, and for having submitted a responsive quotation;

WHEREAS, as provided for in the GPPB Manual of Procedures for the Procurement of Goods and Services, Volume 2, the concept of value for money is not restricted to price and includes non-cost factors like suitability of fitness to the purpose, quality, etc. among other factors including completeness and compliance to the requirements;

WHEREAS, the proposal of **VIVA SALES ENTERPRISES** for the **Supply and delivery of One (1) lot of Various Supplies and Materials for Repair of the Agency Offices** conforms to the requirements of PIA and the law and its price quotation of **One Hundred Sixty-Four Thousand Pesos Only (Php 164,000.00)**, inclusive of tax, is within the ABC, and thereby rendering the same as a responsive quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, in consideration of the foregoing, **WE**, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMEND** the award via *Small Value Procurement* to **VIVA SALES ENTERPRISES** for the **SUPPLY AND DELIVERY OF ONE (1) LOT OF VARIOUS SUPPLIES AND MATERIALS FOR REPAIR OF THE AGENCY OFFICES** in the amount of **ONE HUNDRED SIXTY-FOUR THOUSAND PESOS ONLY (Php 164,000.00)** inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
