**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via
SMALL VALUE PROCUREMENT TO GBR-GEN GENERAL MERCHANDISE
FOR LOT 1 - VEHICLE TIRES AND FLEETSERV INC. FOR
LOT 2 - VEHICLE BATTERY AND LOT 3 - VEHICLE PARTS,
ACCESSORIES, AND MAINTENANCE SUPPLIES**

WHEREAS, the Philippine Information Agency – Administrative Division (ADMIN) submitted its Purchase Request for the **Supply and delivery of Motor Vehicle Parts, Accessories, and Maintenance Supplies (Lots 1-3)** with an Approved Budget for the Contract (ABC) of **SIX HUNDRED EIGHTY-NINE THOUSAND EIGHT HUNDRED PESOS ONLY (Php 689,800.00)**, inclusive of tax and included in the Annual Procurement Plan of the Agency;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H – Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website, the official website of the PIA as Procuring Entity, PIA social media platforms and sent the same to various prospective suppliers on 22 September 2023;

WHEREAS, the Purchase Request and posting was divided into three (3) lots with details as follows:

WHEREAS, after the closing date on 2 October 2023, the following suppliers submitted their quotations namely 1) GBR-GEN General Merchandise; 2) FleetSERV Inc; 3) EGMJ Trading; 4) DMC Master Tires General Merchandise; 5) Sure Tire Trading; and 6) Faircare Trading Corporation appearing herein as ANNEX A and the Abstract of Quotation as ANNEX B;

WHEREAS, the following suppliers submitted the lowest quotations namely GBR-GEN General Merchandise for LOT 1 – Vehicle Tires, and FleetSERV Inc. for LOT 2 – Vehicle Battery and LOT 3 – Vehicle Parts, Accessories, and Maintenance Supplies. The aforesaid suppliers were subjected to post qualification evaluation by the designated member of the Technical Working Group (TWG) on 12 October 2023;

WHEREAS, after careful evaluation, validation, and verification of all the legal, technical, and financial requirements of the subject procurement, the TWG found that the submitted quotation of **GBR-GEN General Merchandise** for *LOT 1 – Vehicle Tires*, and **FLEETSERV Inc.** for *LOT 2 – Vehicle Battery* as well as *LOT 3 – Vehicle Parts, Accessories, and Maintenance Supplies* conforms to the requirements of PIA and the law and its price quotation of **TWO HUNDRED TWO THOUSAND EIGHT HUNDRED FIFTY-SIX PESOS ONLY (Php 202,856.00)** for *LOT 1*, **ONE HUNDRED EIGHT THOUSAND EIGHT HUNDRED PESOS ONLY (Php 108,800.00)** for *LOT 2*, and **TWO HUNDRED FIFTY-SEVEN THOUSAND NINE HUNDRED TWELVE PESOS ONLY (Php 257,912.00)** for *LOT 3*, were inclusive of tax, are within the ABC, and are the most economical and advantageous to the government, thereby rendering both as the Lowest Calculated and Responsive Quotations;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, for all and in consideration of the foregoing, **WE**, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMEND** the award of contract via *Small Value Procurement (53.9)* to:
