**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via
SMALL VALUE PROCUREMENT TO GOODIE FOODIE DINER FOR THE
PROCUREMENT OF PACKED MEALS & SNACKS FOR THE ATTENDEES
OF TECHNICAL ASSISTANCE ON QUALITY MANAGEMENT SYSTEM
TRANSITION TO ISO 9001:2015 STANDARD**

WHEREAS, the Philippine Information Agency – Knowledge and Quality Management (KQM) submitted a Purchase Request for the **PROCUREMENT OF PACKED MEALS & SNACKS FOR THE ATTENDEES OF TECHNICAL ASSISTANCE ON QUALITY MANAGEMENT SYSTEM TRANSITION TO ISO 9001:2015 STANDARD** with an Approved Budget for the Contract (ABC) of **SEVENTY-NINE THOUSAND TWO HUNDRED PESOS ONLY (PHP 79,200.00)** inclusive of tax and included in the Supplemental Annual Procurement Plan of the Agency;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS, PIA website, social media account, bulletin board and sent the same to the various prospective suppliers on **05 September 2023**;

WHEREAS, after the closing date on 11 September 2023, six (6) prospective suppliers submitted their quotations namely; 1) Marquay Trading OPC, 2) Dara Consumer Goods Trading, 3) Goodie Foodie Diner, 4) Lai's Catering Services, 5) Cheenee's Catering Services, and 6) Kitchengarten Events Corp. appearing herein as ANNEX A and the Abstract of Quotation as Annex B;

WHEREAS, hereunder is the summary of the price quotations received:

WHEREAS, the following are the results of the evaluation and deliberation of the quotations received;

MARQUAY TRADING OPC	<p>Submitted the lowest quotation and was subjected to Post Qualification Evaluation on 20 Sept 2023.</p> <p>The TWG found the bidder is non-compliant with the legal requirements, particularly on its Business Permit, which is "Wholesale" on a fee or contract basis of machinery, equipment, and supplies. This is in contrary to the services being procured.</p>
DARA CONSUMER GOODS TRAINING	<p>Submitted the 2nd lowest quotation.</p> <p>The TWG found that the bidder is non-compliant with the legal requirements, particularly on its business permit, which is on "Trading" and is not directly connected to catering services. This raises concerns about the assurance of food safety during handling and preparation. Moreover, the location is significantly distant from the intended food delivery site. This can</p>

	bring concerns about the potential impact on food quality and preservation of its freshness.
GOODIE FOODIE DINER	<p>Submitted the 3rd lowest quotation and was subjected to Post Qualification Evaluation on 21 Sept 2023.</p> <p>The TWG ascertained that the bidder met all the requirements and technical specifications outlined by the end user. Moreover, the TWG also noted the bidder's accessible location which adds to their competitive advantages. Goodie Foodie Diner passed the site inspection, thus, illustrating the firm's commitment to upholding food safety regulations.</p>

WHEREAS, after review and evaluation of the submitted quotation and other eligibility documents, the TWG found that Goodie Foodie Diner is legally, financially, and technically capable to undertake the subject procurement, thus, their quotation is deem responsive;

WHEREAS, the proposal of **GOODIE FOODIE DINER** conforms to the requirements of PIA and the law and its price quotation of **Seventy-Six Thousand Three Hundred Twenty Pesos Only (PHP 76,320.00)** inclusive of tax, is within the ABC, and the most economical and advantageous to the government, thereby rendering the same as the Lowest Calculated and Responsive Quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, in consideration of the foregoing, WE, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMENDS** the award via Small Value Procurement to **GOODIE FOODIE DINER** for the **PROCUREMENT OF PACKED MEALS & SNACKS FOR THE ATTENDEES OF TECHNICAL ASSISTANCE ON QUALITY MANAGEMENT SYSTEM TRANSITION TO ISO 9001:2015 STANDARD** in the amount of **SEVENTY-SIX THOUSAND THREE**

HUNDRED TWENTY PESOS ONLY (PHP 76,320.00) inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
