RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via SMALL VALUE PROCUREMENT TO METOS OFFSHORE, INC. FOR THE PROCUREMENT OF MULTIMEDIA SOFTWARE LICENSE - CREATIVE CLOUD ALL APPS FOR ONE (1) YEAR SUBSCRIPTION (PR-23-09-082)

WHEREAS, the Philippine Information Management Information Systems Division (MISD), submitted its Purchase Request for the PROCUREMENT OF MULTIMEDIA SOFTWARE LICENSE – CREATIVE CLOUD ALL APPS FOR ONE (1) YEAR SUBSCRIPTION with an Approved Budget for the Contract (ABC) of FIFTY THOUSAND PESOS ONLY (Php 50,000.00) inclusive of tax and included in the Supplemental Annual Procurement Plan of the Agency;

**WHEREAS**, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

**WHEREAS**, the PIA-BAC recommends the use of Small Value Procurement (Sec 53.9) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS, PIA's website, social media account, bulletin board and sent the same to various prospective suppliers on 10 October 2023;

**WHEREAS**, after the closing date on 13 October 2023 the following prospective service providers namely 1) Metos Offshore, Inc. 2) Bayan PC Technologies Inc. and 3) Ynzal Marketing Corp submitted their quotation appearing herein as ANNEX A and the Abstract of Canvass as ANNEX B;

WHEREAS, hereunder is the summary of the price quotations received;

**WHEREAS,** Metos Offshore, Inc submitted the lowest calculated quotation and was subjected to Post Qualification Evaluation by the designated TWG Representative on 13 November 2023;

WHEREAS, after evaluation of the submitted quotation and other eligibility documents, the proposal of METOS OFFSHORE, INC conforms to the requirements of PIA and the law and its price quotation of FORTY-SEVEN THOUSAND SEVEN HUNDRED SEVENTY-SEVEN PESOS ONLY (PHP 47,777.00) inclusive of tax, is within the ABC, and most economical and advantageous to the government, thereby rendering the same as the Lowest Calculated and Responsive Quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

**NOW, THEREFORE,** for all and in consideration of the foregoing, WE, the Members of the PIA BIDS AND AWARDS COMMITTEE, by virtue of the powers vested on us by law, hereby RECOMMENDS to award via Small Value Procurement to METOS OFFSHORE, INC for the PROCUREMENT OF MULTIMEDIA SOFTWARE LICENSE - CREATIVE CLOUD ALL APPS FOR (1) YEAR SUBSCRIPTION (PR-23-09-082) in the amount of FORTY-SEVEN THOUSAND SEVEN HUNDRED SEVENTY-SEVEN PESOS **ONLY (PHP 47,777.00)** inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
