- c. Thirty Percent (30%) of the Total Contract Price of Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security.

You are likewise required to formally enter into a Contract Agreement with the Agency within ten (10) calendar days from the receipt of this Notice and further to confer with the PIA-BAC Secretariat, for instructions regarding the execution of this award.

Failure to provide the Performance Security shall constitute sufficient grounds for recission of the award and forfeiture of the Bid Security.
