**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via
SMALL VALUE PROCUREMENT TO GLYPTIC ART ENTERPRISE FOR
THE SUPPLY AND DELIVERY OF EIGHTY (80) PCS CUSTOMIZED
PLAQUE FOR PRAISE AWARDEES**

WHEREAS, the Philippine Information Agency – Office of Director-General (ODG) submitted its Purchase Request for the **Supply and Delivery of Eighty (80) pcs Customized Plaque for Praise Awardees** with an Approved Budget for the Contract (ABC) of **EIGHTY-EIGHT THOUSAND PESOS ONLY (Php 88,000.00)**, inclusive of tax and included in the Annual Procurement Plan of the Agency;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H – Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website, the official website of the PIA as Procuring Entity, PIA social media platforms and sent the same to various prospective suppliers on 10 December 2024;

WHEREAS, following the closing date on 13 December 2024 and subsequent to an invitation extended via email to various suppliers no received quotation.

WHEREAS, the PIA-BAC reposted the invitation to bid at the PhilGEPS website, the official website of the PIA as Procuring Entity, and PIA social media platforms and sent the same to various prospective suppliers on 20 December 2024;

WHEREAS, after the closing date on 23 December 2024 the following suppliers submitted their quotations namely 1)Glyptic Art Enterprise and 2) Token Avenue Trading, submitted a quotation appearing herein as ANNEX A and the Abstract of Quotation as ANNEX B.

WHEREAS, hereunder is the summary of the quotations received:

WHEREAS, Glyptic Art Enterprise submitted the Lowest Calculated Quotation and has been previously subjected to Post Qualification Evaluation by the designated Technical Working Group (TWG) Representative;

WHEREAS, after careful evaluation, validation, and verification of all the legal, technical, and financial requirements of the subject procurement, the TWG found that the submitted quotation of **Glyptic Art Enterprise for Supply and Delivery of Eighty (80) pcs Customized Plaque for Praise Awardees** conforms to the requirements of PIA and the law and its price quotation of **SEVENTY-EIGHT THOUSAND FOUR HUNDRED PESOS ONLY (PHP 78,400.00)**, inclusive of tax, is within the ABC, and most advantageous to the government, thereby rendering the same as the lowest and most responsive quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, for all and in consideration of the foregoing, **WE**, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMEND** the Award of Contract via *Small Value Procurement (53.9)* to **GLYPTIC ART ENTERPRISE** in the amount of **SEVENTY-EIGHT THOUSAND FOUR HUNDRED PESOS ONLY (PHP 78,400.00)**, inclusive of appropriate taxes and fees for the **SUPPLY AND DELIVERY OF EIGHTY (80) PCS CUSTOMIZED PLAQUE FOR PRAISE AWARDEES**.


This resolution shall take effect immediately.
