**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via
SMALL VALUE PROCUREMENT TO SUN VALLEY MULTI-PURPOSE
COOPERATIVE FOR THE GENERAL CLEANING OF TWENTY-FIVE (25) AIR-
CONDITIONING UNITS**

WHEREAS, the Philippine Information Agency – Administrative Division (Admin) submitted a Purchase Request for the **GENERAL CLEANING OF TWENTY-FIVE (25) AIR-CONDITIONING UNITS** with an Approved Budget for the Contract (ABC) of **SEVENTY THOUSAND PESOS ONLY (PHP 70,000.00)** inclusive of tax and included in the Annual Procurement Plan of the Agency with the details as follows;

WHEREAS, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

WHEREAS, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website and sent the same to the various prospective suppliers on 18 October 2024;

WHEREAS, after the closing date on 25 October 2024, ten (10) prospective suppliers submitted their quotation namely 1. VISIONLITE SYSTEM SOLUTION CORPORATION, 2. SUN VALLEY MULTI-PURPOSE COOPERATIVE, 3. GREEN AIR AIRCONDITIONING SERVICES, 4. VISTAAIRE BUILDERS AND AIRCONDITIONING SALES AND SERVICE INC, 5. AMIGOTEK CORPORATION, 6. PUREKOLD AIRCONDITIONING SERVICES, 7. AIROVATECH INCORPORATED, 8. ALDIN'S AIRCON & REFRIGERATION SYSTEM TRADING, 9. RBROS ENTERPRISES, and 10. VINNO VENTURES SOLUTIONS OPC herein as ANNEX A and the Abstract of Quotation as Annex B;

WHEREAS, hereunder is the summary of the price quotations received:

WHEREAS, the following are the results of the evaluation and deliberation of quotations received;

Prospective Supplier	Recommendation
VISIONLITE SYSTEM SOLUTION CORPORATION	Submitted the lowest quotation and was subjected to Virtual Post Qualification on 5 November 2024. The TWG found the bidder non-compliant with the technical requirement particularly on the use of chemical coil cleaner.
SUN VALLEY MULTI-PURPOSE COOPERATIVE	Submitted the 2 nd lowest quotation and was subjected to Post Qualification Evaluation on 8 November 2024.

WHEREAS, after review and evaluation of the submitted quotation and other eligibility documents, the TWG found that SUN VALLEY MULTI-PURPOSE COOPERATIVE is legally, financially, and technically capable to undertake the subject procurement, thus their quotation is deemed responsive;

WHEREAS, after careful evaluation of the submitted quotation and other eligibility documents, the proposal of SUN VALLEY MULTI-PURPOSE COOPERATIVE conforms to the requirements of PIA and the law and its price quotation of THIRTY-FOUR THOUSAND TWO HUNDRED PESOS ONLY (PHP 34,200.00) inclusive of tax, is within the ABC, and the most economical and advantageous to the government, thereby rendering the same as the Lowest Calculated and Responsive Quotation;

WHEREAS, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE, in consideration of the foregoing, WE, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested on us by law, hereby **RECOMMENDS** the award via Small Value Procurement to SUN VALLEY MULTI-PURPOSE COOPERATIVE for the **GENERAL CLEANING OF TWENTY-FIVE (25) AIR-CONDITIONING UNITS** in the amount of THIRTY-FOUR THOUSAND TWO HUNDRED PESOS ONLY (PHP 34,200.00) inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
