**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT via  
SMALL VALUE PROCUREMENT TO MISCHA KWIN MERCHANDISING FOR  
THE SUPPLY AND DELIVERY OF VARIOUS BUILDING MAINTENANCE  
SUPPLIES AND MATERIALS**

**WHEREAS**, the Philippine Information Agency – Administrative Division (Admin) submitted a Purchase Request for the **SUPPLY AND DELIVERY OF VARIOUS BUILDING MAINTENANCE SUPPLIES AND MATERIALS** with an Approved Budget for the Contract (ABC) of **NINE HUNDRED EIGHTY-SEVEN THOUSAND FOUR HUNDRED EIGHTY-ONE PESOS ONLY (PHP 987,481.00)** inclusive of tax and included in the Annual Procurement Plan of the Agency;

**WHEREAS**, the PIA-BAC as per Art. V, Sec. 12 of Republic Act (RA) 9184 is authorized to recommend to the Head of the Procuring Entity (HoPE) the use of Alternative Methods of procurement for goods and services as provided in Rule XVI of RA 9184 and its Revised 2016 Implementing Rules and Regulations (IRR);

**WHEREAS**, the PIA-BAC recommends the use of Small Value Procurement (SVP) as contained in the 2016 Revised IRR of RA 9184 Annex H - Consolidated Guidelines for Alternative Methods of Procurement and cause the posting at the PhilGEPS website and sent the same to the various prospective suppliers on 5 November 2024;

**WHEREAS**, after the closing date on 12 November 2024, two (2) prospective suppliers submitted their quotation namely 1. VIVA SALES ENTERPRISES, and 2. MISCHA KWIN MERCHANDISING herein as ANNEX A and the Abstract of Quotation as Annex B;

**WHEREAS**, hereunder is the summary of the price quotations received;

Prospective Supplier	Price Quotation (PHP)
1. VIVA SALES ENTERPRISES	879,650.00
2. MISCHA KWIN MERCHANDISING	971,192.00

**WHEREAS**, the following are the results of the evaluation and deliberation of quotations received;

<b>Prospective Supplier</b>	<b>Recommendation</b>
VIVA SALES ENTERPRISES	Submitted the lowest quotation and was subjected to Post Qualification Evaluation on 21 November 2024.  The TWG found the bidder non-compliant with the technical requirement particularly on the quantity of the TL5 Essential.
MISCHA KWIN MERCHANDISING	Submitted the 2nd lowest quotation and was subjected to Post Qualification Evaluation on 27 November 2024.

**WHEREAS**, after review and evaluation of the submitted quotation and other eligibility documents, the TWG found that MISCHA KWIN MERCHANDISING is legally, financially, and technically capable to undertake the subject procurement, thus their quotation is deemed responsive;

**WHEREAS**, after careful evaluation of the submitted quotation and other eligibility documents, the proposal of MISCHA KWIN MERCHANDISING conforms to the requirements of PIA and the law and its price quotation of **Nine Hundred Seventy-One Thousand One Hundred Ninety-Two Pesos Only (971,192.00)** inclusive of tax, is within the ABC, and the most economical and advantageous to the government, thereby rendering the same as the Single Calculated and Responsive Quotation;

**WHEREAS**, Section 12 of RA 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative;

**NOW, THEREFORE**, in consideration of the foregoing, WE, the Members of the **PIA BIDS AND AWARDS COMMITTEE**, by virtue of the powers vested in us by law, hereby **RECOMMENDS** the award via Small Value Procurement to **MISCHA KWIN MERCHANDISING** for the **SUPPLY AND DELIVERY OF VARIOUS BUILDING MAINTENANCE SUPPLIES AND MATERIALS** in the amount of **Nine Hundred Seventy-One Thousand One Hundred Ninety-Two Pesos Only (971,192.00)** inclusive of appropriate taxes and fees.

This resolution shall take effect immediately.
