



CONTRACT AGREEMENT FORM PR_NO.24-12-138_PIACPSD2024 ENGAGEMENT OF SERVICES FOR VOICE TALENT CASTER

THIS AGREEMENT made this ____ day of 0 2025 2024 between the **PHILIPPINE INFORMATION AGENCY (PIA)**, a government agency of the Philippines with office address at PIA Building, Visayas Avenue, Diliman, Quezon City, represented herein by its Deputy Director-General, **WILSON T. BUERANO JR.**, with authority under PIA Office Order No. 171 series of 2023, hereinafter referred to as **PIA** of the one part and **TERENCE GIL A. GUILLERMO** Artist/Individual Local Consultant herein referred to as "**CONTRACTOR**" with office address at 17B White St., Carmel V. Subd. Brgy. Tandang Sora, Quezon City of the other part;

WHEREAS, the PIA solicited Bids for certain goods and ancillary services, particularly for the ENGAGEMENT OF SERVICE FOR VOICE TALENT CASTER and has accepted a Bid from the MR. TERENCE GIL A. GUILLERMO in the sum of FIFTY THOUSAND PESOS (Php 50,000.00) hereinafter called "the Contract Price", payable upon receipt of the billing statement including all taxes and subject to government accounting rules and regulations.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- I. The following documents shall be deemed to form and be read and construed as an integral part of this Agreement, *viz.*:
 - a. Purchase Request No. 24-12-138
 - b. Terms of Reference
 - c. Supplier Quotation and Request for Quotation
 - d. Statement of Compliance
 - e. Omnibus Sworn Statement (OSS)

II. OBLIGATIONS OF THE PARTIES



- a. That the Contractor shall provide service for the Engagement of Services for Voice Talent Caster.
- b. That the Contractor shall strictly comply with the Terms of Reference of this Agreement.
- c. The Contractor warrants that: (a) Services will be performed in a timely, efficient, and professional manner; (b) all Contractor personnel assigned to perform Services will have the necessary skill and training; and (c) Services will be performed in a manner consistent with the standard of care in the industry ("Services Warranty"); (d) the Contractor covenants with the PIA to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.



d. For its services, the payment shall be processed upon successful delivery of the services indicated in the Terms of Reference as evidenced by the submission and acceptance of the required deliverables of the **PIA**.

III. EFFECTIVITY AND DURATION

This Agreement shall take effect immediately, upon signing of the parties and shall remain in force and effect until full completion.

IV. LIQUIDATED DAMAGES

In the event that the Contractor violates any of the terms and conditions of this Contract, or neglects to perform in a timely manner any of the works, duties, functions, responsibilities or obligations stipulated herein, inclusive of the duly granted time extension, if any, or fails to carry out the tasks herein required in an acceptable manner for any reason whatsoever, the Contractor shall be liable for damages for such failure, and shall pay the **PIA** liquidated damages in an amount equivalent to one-tenth (1/10) of one (1%) percent of the total contract price for every day of delay of breach, without need for any notice or demand from the **PIA**, in addition to other remedies that the **PIA** may exercise under this contract, pertinent laws, rules and regulations, until such services are finally delivered and accepted by the **PIA**.

V. TERMINATION OF CONTRACT

The **PIA** reserves the right to terminate this Contract for any cause which may include failure of the Contractor to perform in a timely and acceptable manner any of their works, duties, functions, responsibilities or obligations stipulated herein or failure to carry out the task herein required in a manner acceptable to the **PIA** or violation by the Contractor of any of the terms and conditions of this Contract, subject to sanctions and remedies provided for herein and under the pertinent laws, rules and regulations.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


